COMMON MISCONCEPTIONS ABOUT LONG-TERM CARE

Most of us know of someone who requires long-term care (LTC); however for ourselves & our families we usually take the "not us" attitude. For "us" not to consider such possibility is a mistake and some thought should be given to the following misconceptions: "I will never need LTC." Once reaching age 70 there is approximately a 70% chance of requiring LTC, either temporary or perpetual. We are living longer, so be mindful of that. "My spouse or children will take care of me." Making that assumption is problematic as we do not know the level of care needed, time & skill required, nor the health of our spouse and ability of our children come such time. "Medicare will pay for LTC." Medicare may pay up to 100 days of skilled care under certain circumstances; however beyond that period you are on your own.

Snow and ice increases one's

Living Trusts vs. Wills

Both living trusts and wills serve as a way to transfer property once you have passed away. The differences, however, are very important when putting your estate plan in place.

Living	Trust

Advantages

- Avoid the expense and delay of probate proceedings
- If you own property in another state, it eliminates the need to probate that property in that state.
- Can immediately transfer management of your property if
- you become incapacitated
- It remains confidential and does not become a matter of public record.
- Enables you to name someone you trust to manage trust property for young benefi-

Setting up a trust requires quite a bit of initial paperwork

Disadvantages

- Requires the transfer of ownership of any property you want held in the trust
- Creditors do not have a final cut-off date for bringing claims against your trust

- Take a deep breath and stay calm
- Check for injuries; call an ambulance when in doubt
